Application for Re-registration of manually registered BDS (Bachelor of Dental Surgery) dentists	Applicants who registered their BDS degree with the Assam State Dental Council before 1st January 2024 and hold Registration Nos. between 0001-A to 4029-A (inclusive) and have renewed their registration till 31st March 2027 are eligible. Thereafter, the registration certificate must be valid for at least six months from the date of submission. Dentists who have not renewed their registration must do so manually at the O/o Assam State Dental Council, Guwahati, presenting their registration certificate signed by both President and Registrar.
2.	Application for Re-registration of manually registered MDS (Master of Dental Surgery) dentists	Applicants who registered their MDS degree with the Assam State Dental Council before 1st January 2024 and hold Registration Nos. between 0001-A to 4029-A (inclusive) and have renewed their registration till 31st March 2027 are eligible. Thereafter, the registration certificate must be valid for at least six months from the date of submission. Dentists who have not renewed their registration must do so manually at the O/o Assam State Dental Council, Guwahati, presenting their registration certificate signed by both President and Registrar.
3.	Application for New Registration of BDS degree	Applicants who have completed their Compulsory Rotatory Internship and have not registered in any other State Dental Council are eligible.

4.	Application for Delay in Registration of BDS degree	Applicants who have completed their Compulsory Rotatory Internship and have not registered in any State Dental Council within 180 days (six months) from the date of completion of internship are eligible.
5.	Application for Registration of Additional Degree (MDS)	Applicants who currently hold BDS registration with the Assam State Dental Council and have completed their MDS degree. Dentists registered after 1st January 2024 (Registration Nos. from 4030-A onwards) are directly eligible. Those registered before 1st January 2024 (0001-A to 4029-A) must first apply for Re-registration of manually registered BDS dentists before applying for this service.
6.	Application for Transfer of Registration of BDS degree from other State Dental Council	Applicants with BDS registration in another State Dental Council, outside Assam, who wish to transfer registration to Assam with due permission from the originally registered council are eligible.

Application for Transfer of Registration of BDS and MDS degree from other State Dental Council	Applicants with BDS and MDS registration in another State Dental Council, outside Assam, who wish to transfer registration to Assam with due permission from the originally registered council are eligible.
8.	Application for New Registration of Dental Mechanic/Dental Hygienist	Applicants who have completed the Dental Mechanic or Dental Hygienist course and have not registered in any other State Dental Council are eligible.
9.	Application for Delay in Registration of Dental Mechanic/Dental Hygienist	Applicants who have completed the Dental Mechanic or Dental Hygienist course and have not registered in any State Dental Council within 180 days (six months) from the date of course completion are eligible.

Application for Transfer of Registration of Dental Mechanic/Dental Hygienist from other State Dental Council	Applicants with a diploma in Dental Mechanic/Dental Hygienist registered in another State Dental Council, outside Assam, who wish to transfer registration to Assam with due permission are eligible.
11.	Application for Provisional Registration (After passing Fourth Year BDS and before Compulsory Rotatory Internship)	Applicants who have passed Fourth/Final Year BDS and will undergo Compulsory Rotatory Internship in a DCI-recognized dental college are eligible.
12.	Application for Renewal of Registration of BDS/MDS degree	Applicants who currently hold BDS/MDS registration with Assam State Dental Council are eligible. Dentists registered after 1st January 2024 (Registration Nos. from 4030-A onwards) are directly eligible. Those registered before 1st January 2024 (0001-A to 4029-A) must first apply for Re-registration of manually registered BDS/MDS dentists.
