

AFFIDAVIT

I, _____, Son/Daughter of _____, aged about _____ years, resident of _____, do hereby solemnly affirm and state as follows:

1. That I am a BDS graduate from _____ (Name and address of the Dental College), but did not obtain the required score in NEET (UG) 2016 for admission into the BDS course in any dental college in India at that time.
2. That the matter was sub judice before the Hon'ble Rajasthan High Court in S.B. Civil Writ Petition No. 13776/2017 which I did not inform about the said proceedings at the time of applying for registration before the Assam State Dental Council.
3. That I was earlier registered as a Dental Surgeon in the Part-A of the Dentists Act, 1948, as amended, by misrepresentation vide Registration No. _____. A judgment was subsequently passed by the Hon'ble Rajasthan High Court in D.B. Special Appeal (Writ) No. 911/2018. and my registration was subsequently cancelled vide Order dated 12-06-2023 under Section 41(1)(i) of the Dentists Act, 1948 (as amended).
4. That I state that my admission and BDS degree stand regularised in terms of the judgment passed by the Hon'ble Supreme Court of India in *Civil Appeal No(s). _____ of 2025 (Arising out of SLP (C) No(s). 14014-14019 of 2023 and connected matters)*, titled **Siddhant Mahajan & Ors. vs. State of Rajasthan & Ors.**, decided on 18th December, 2025.
5. That in compliance with the directions of the Hon'ble Supreme Court under Article 142 of the Constitution of India, I have filed the required affidavit before the Registrar (Judicial), Rajasthan High Court, Jodhpur, within the stipulated time, giving an unconditional undertaking to render pro-bono services to the State of Rajasthan as and when required, in terms of the said judgment.
6. That I hereby submit this affidavit before the Assam State Dental Council seeking restoration of my Registration No. in the State Dental Register in light of the aforesaid judgment of the Hon'ble Supreme Court.
7. That I have not registered my BDS Degree with any State Dental Council in India after the cancellation of my registration by the Assam State Dental Council vide Order dated 12-06-2023 under Section 41(1)(i) of the Dentists Act, 1948 (as amended), up to the date of swearing this affidavit.
8. That I have not practised dentistry in any clinic, hospital, dental institution, or any other dental or related establishment anywhere in India during the aforesaid period.
9. That no criminal, civil, or disciplinary case is pending against me before any court of law, tribunal, or authority in any State of India.

10. That I declare that I have not engaged in any unethical, illegal, or professional misconduct during the period in question.
11. That the statements made hereinabove are true and correct to the best of my knowledge and belief, and nothing material has been concealed therefrom.
